A membership shall pass with a licence upon conveyance or other disposition of the land to which the licence is appurtenant.

The respective interests of the members of the Community, as provided under Section 54 of the *Water Act*, shall be determined as follows:

- The diversion interests for works on Monte Creek located at point of diversion identified as PD49460 and diversion works (channel) located at diversion point identified as PD50212 at outlet of Monte Lake shall be determined by the aforesaid diversion licences.
- The storage interests for works (dam) on Pringle Creek at storage site identified as PD50213 shall be determined by those portions of the aforesaid diversion licences that are supported by storage.

The provisions in Sections 52 to 61 of the Water Act govern the Community.

This Certificate of Incorporation replaces the Certificate of Incorporation issued by the Deputy Comptroller of Water Rights on May 31, 1999 and any amendments thereto.
