THIS IS TO CERTIFY THAT the holders of the water licences mentioned herein are incorporated into a water users' community named the Silver Creek Water Users' Community (the "Community"):

The Community is incorporated to undertake the supply of water from Silver Creek to the properties of the members of the Community, for use as authorized by the licences mentioned on attached Schedule "A".

A membership shall pass with a licence upon conveyance or other disposition of the land to which the licence is appurtenant.

The provisions in Sections 52 to 61 of the *Water Act* govern the Community.

This Certificate of Incorporation replaces the Certificate of Incorporation issued by the Comptroller of Water Rights on October 21, 1976 and any amendments thereto.
