The Community is incorporated to undertake the supply of water from Duhamel Creek to the properties of the members of the Community for purposes as set out herein.

The members of the Community are the holders of the licences mentioned herein.

A membership shall pass with a licence upon conveyance or other disposition of the land to which the licence is appurtenant.

The provisions in Sections 52 to 61 of the *Water Act* govern the Community.

This Certificate of Incorporation replaces the Certificate of Incorporation issued by the Deputy Comptroller of Water Rights on January 5, 1998.
