# Certificate of Incorporation of the White Lake/White Creek Water Users' Community

### File No. 3002362

Having received petitions to establish a water users' community from the holders of water licences which authorize the diversion of water from White Creek; and

WHEREAS the petitioners are prepared to participate in the construction, maintenance and operation of a storage dam on White Lake and would benefit from the release of water from storage to supplement their supply available for irrigation purpose; and

WHEREAS I consider that the incorporation of a water users' community, pursuant to Section 52 of the Water Act, would serve in the best interests of the said petitioners and further applicants for water licences within the White Creek Watershed,

I HEREBY incorporate a water users' community as follows:

- 1) The name of the Water Users' Community is the White Lake/White Creek Water Users' Community.
- 2) The purpose of the Water Users' Community shall be to construct, operate and maintain a storage dam on White Lake in accordance with a licence to be granted for storage purpose in the name of the Community.

- 3) With respect to the following licences, 65% of the water members are entitled to divert for irrigation purpose will be supported by storage provided on White Lake, therefore the following quantities will determine the respective interests of these members proportionate to their share of the total volume of water supported by storage:

- 4) With respect to any further licences to be included within the Water Users' Community, these shall be totally supported by storage provided on White Lake, unless stated otherwise.
- 5) Each members rights granted herein are transferable to the successors-intitle of the parcels of land appurtenant to the aforementioned licences or any licences issued in substitution thereof.
- 6) Pursuant to Section 54(2) of the Water Act, I hereby appoint Renzo Schaafsma as first Manager of the Water Users' Community.
