

Water Act Section 61(1) Recall and Re-Issue of the Certificate of Incorporation of the White Lake/White Creek Water Users' Community

In the matter of the Certificate of Incorporation of the White Lake/White Creek Water Users' Community issued by the Deputy Comptroller of Water Rights on the 7th day of October, 1994.

WHEREAS Part (3) of said Certificate of Incorporation states that 65% of the irrigation rights held by each member are to be supported by storage, and that this quantity is to be used to determine each members' proportionate interest in the community; and

WHEREAS it has been determined that the amount of irrigation rights to be supported by storage was erroneously estimated; and

WHEREAS it has been determined that storage is required only to support irrigation rights which are authorized for use up to September 30 each year, thereby excluding Conditional Water Licences 56301 & 56303, which authorize short term irrigation rights (to July 31), from membership of said Community, I hereby recall said Certificate of Incorporation and issue the following in lieu thereof:

- 1) The name of the Water Users' Community shall be White Lake/White Creek.
- 2) The Water Users' Community is incorporated for the purposes of constructing, operating and maintaining a storage structure at the outlet of White Lake, tributary to White Creek in the Kamloops Water District, in order to supply storage for certain full term (April 1 to September 30) irrigation rights and future water rights that may be authorized in the White Creek Watershed.
- 3) In respect to the following storage licence the Water Users' Community is given all the powers set out in Section 52 of the Water Act:

4) Wix espect to the following licences that authorize full term (April 1 to September 30) irrigation use, 30% of the water that members are entitled to divert for irrigation purpose will be supported by storage provided in White Lake, whereby the following quantities will determine the extent of the respective interests of these members proportionate to their share of the total volume of water supported by storage:

- 5) With respect to the aforementioned licences, any licences issued in substitution thereof for irrigation purpose shall be subject to the same proportionate interests as set out above.
- 6) With respect to any additional licences which may be included within the Water Users' Community, such licences shall be totally supported by storage provided under Conditional Water Licence 105691, unless otherwise stated.
- 7) Each members' rights granted herein are transferable to the successors-in-title of the parcels of land appurtenant to the licences included within the membership.
